

Installation Instructions

1. Stop compressor air to blast pot.
2. Depressurize blast pot.
3. Using a pipe wrench, unfasten air pipe coupling from ball valve (see right).
4. Insert Farrow Flow between ball valve and the air pipe coupling to the air pipe as shown.
HAND TIGHTEN ONLY!
5. Start compressor and pressurize system.
6. After an hour of use, hand tighten insert again since heat will cause expansion.

PLEASE NOTE: Dosing valve should be adjusted after installation since less media will be needed to blast.

⚠ CAUTION

- TO CLEAN THE FARROW FLOW INSERT, USE MILD SOAP AND WATER ONLY!
- DO NOT use cleansing agents such as acetone, benzene, carbon tetrachloride, gasoline, toluene etc. which are damaging to the plastic.
- HAND TIGHTEN IN INSTALLATION ONLY!
- Do not use wrenches or pipe grips on the Farrow Flow as this could cause damage to the insert.
- Insert may be hot after use. Let the insert cool before unscrewing from air line if hot to the touch.


Please review all safety data and follow manufacturer recommendations for safe handling and performance.

- DISCONNECT COMPRESSED AIR TO BLAST POT BEFORE DISCONNECTING AND INSTALLATION OR REMOVAL OF THE FARROW FLOW INSERT.
- DEPRESSURIZE BLAST POT AND ALL AIR LINES CONNECTED TO THIS PRODUCT BEFORE INSTALLATION OR REMOVAL.
- FARROW FLOW DESIGNED TO BE USED WITH 1.25" NPT THREAD SMOOTH FEMALE AND MALE CONNECTIONS. DO NOT MODIFY THREADS TO THE FARROW INSERT IN ANY WAY.
- AFTER INSTALLATION OR REMOVAL OF THE FARROW FLOW INSERT, CONNECTIONS SHOULD BE CHECKED AND CONNECTION TESTED FOR PROPER FUNCTION AND LEAKAGE. IF AUDIBLE LEAKAGE IS PRESENT, DO NOT PUT INTO USE AND RECONNECT ALL LINES AND REPEAT THE PROCEDURE UNTIL NO LEAKS ARE PRESENT.

✓ INSTALLATION

1. Stop compressor air to blast pot.
2. Depressurize blast pot
3. Using two pipe wrenches, unfasten air pipe coupling from ball valve (see below).
4. Insert Farrow Flow between ball valve and the air pipe coupling to the air pipe as shown. HAND TIGHTEN ONLY!
5. Start compressor and pressurize system.
6. Operate system as usual adjusting pressure and media dosage accordingly.

PLEASE NOTE: After one hour, hand tighten insert again since heat will cause some expansion during use.
